#### Claim Procedures 索償程序

- 1. Report the accident to the agent, brokers or our Claims Department immediately. 意外發生後,請儘快通知保險代理,經紀或本公司賠償部。
- Take all practical steps to mitigate the loss / damage. 採取一切可行的步驟減少損失 / 損毀。
- 3. Report to police immediately in case of theft, burglary, robbery or malicious damage. 如遭盜竊、爆竊、搶劫或惡意破壞,請立即向警方報案。
- 4. Take photos of the accident scene and damaged properties. 拍攝事故現場和損毀財產之照片。
- 5. Do not dispose of the damaged properties. 不要丟棄或自行處理受損之財物。
- 6. Do not commence any repair work without the Company's prior written consent. 在未取得本公司的書面同意之前,請不要開始任何維修工程。
- 7. Cooperate and assist the loss adjuster when called upon. 當公證行派員檢查損毀財物,請配合及協助。
