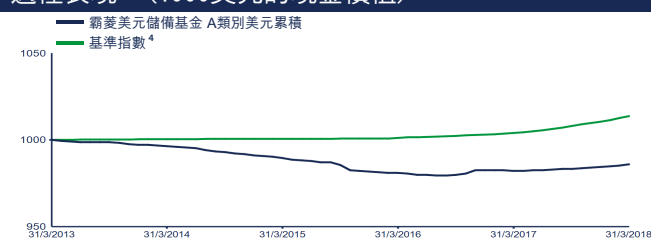

The policy of the Investment Manager of the Fund is to invest in deposits and in negotiable fixed and floating rate securities. Fixed rate securities which may be purchased include certificates of deposit, short term bonds, notes, government securities and other money market instruments provided they are redeemable or repayable within twelve months. Floating rate securities are purchased provided the coupon attaching is due to be refixed within six months of the date of purchase.

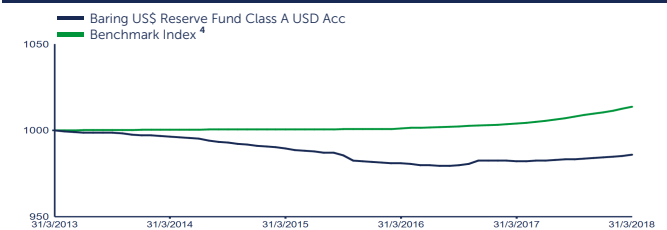
