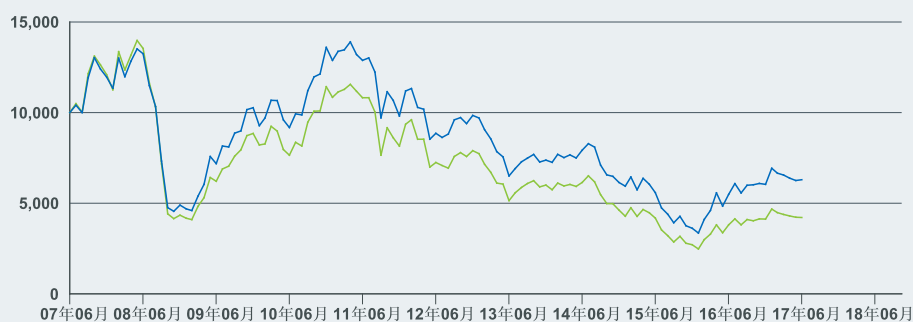

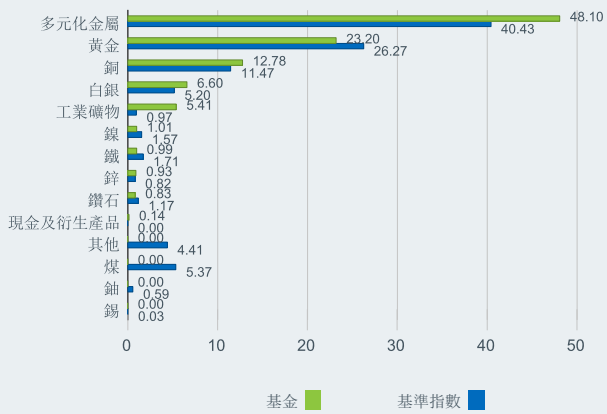

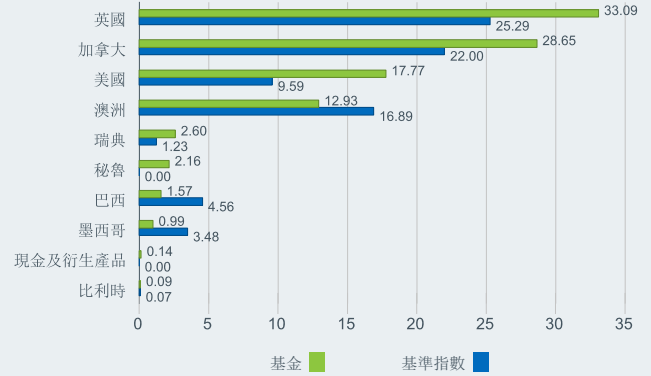

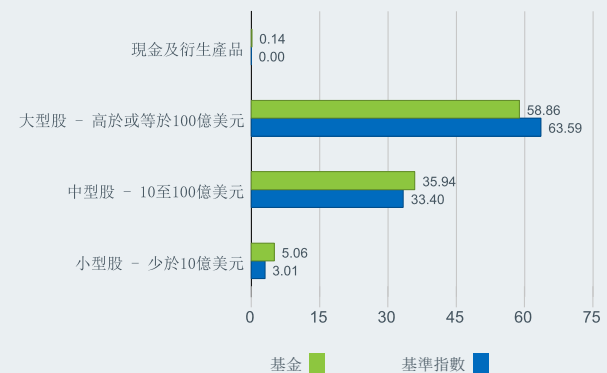

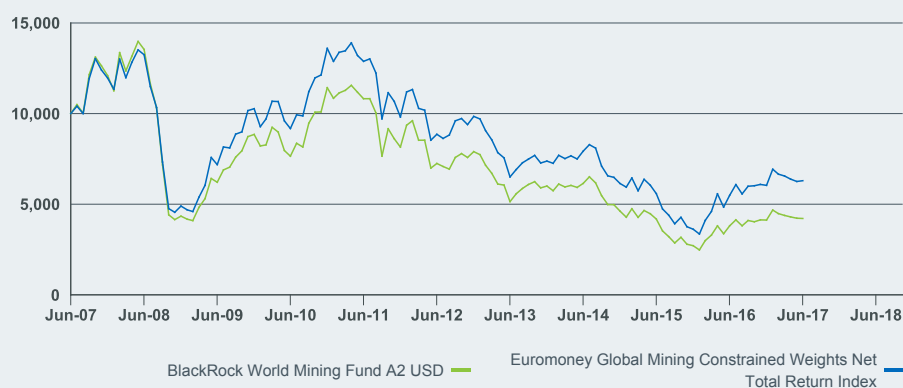

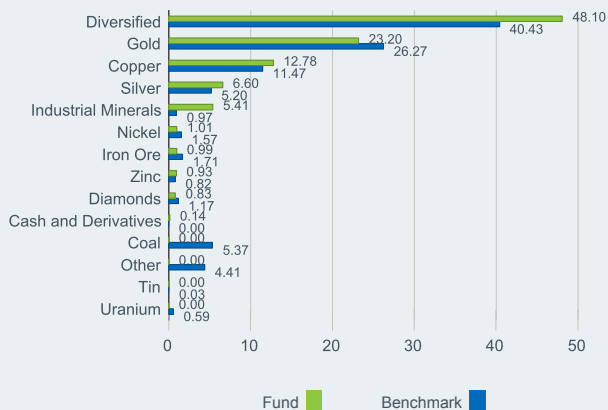

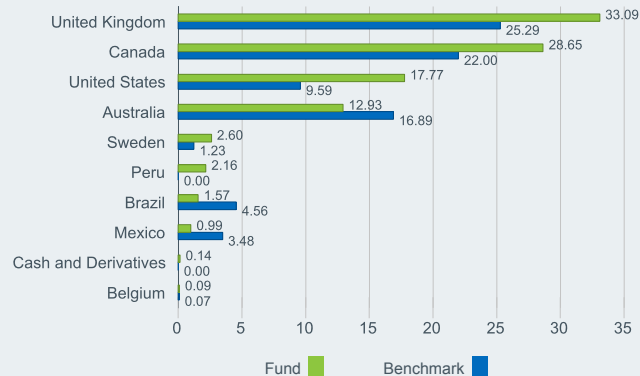

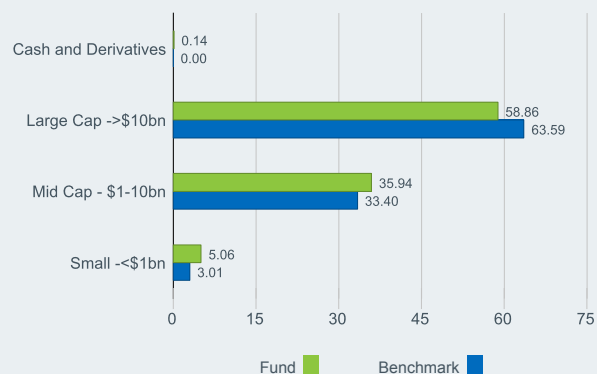

On 30 September 2015, the performance benchmark of the World Mining Fund changed from Euromoney Global Mining Index to Euromoney Global Mining Constrained Weights Net Total Return Index. The rationale for the change is that the new benchmark reflects the UCITS concentration limits to which the Fund's portfolio is managed and is therefore a more accurate, appropriate and fair comparison for the Fund. The new benchmark has been applied to the performance history of the Fund back to inception. The change does not affect how the Fund is currently managed.

Prior to 1 May 2015 the Fund was managed by Evy Hambro and Catherine Raw. Effective 14 February 2014, the Benchmark is renamed to Euromoney Global Mining Index.
