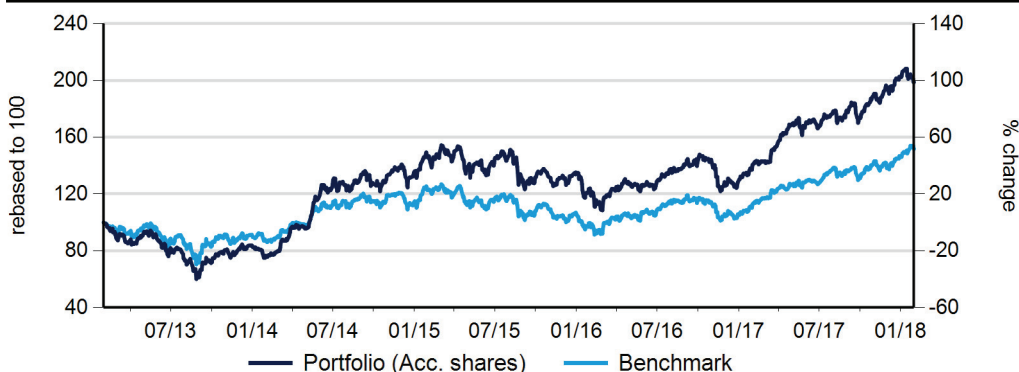

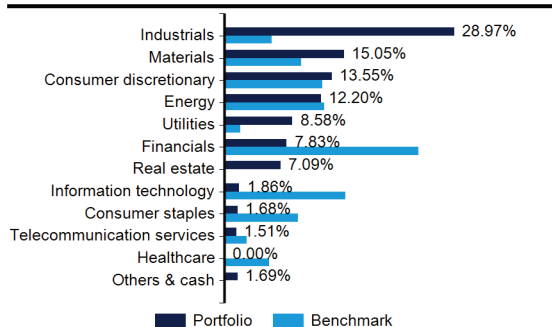

Prior to 12 February 2013, the performance of A2U share class of Amundi Funds Equity India Infrastructure is that of AU share class of the Sub-Fund. The AU share class is not authorized by the Commission in Hong Kong and not available to the public of Hong Kong. With effect from 15 July 2011, the reference indicator of the sub-fund was changed from 100% India BSE Sensex 30 to 10/40 MSCI India. Effective 24 June 2011, Amundi Funds India Infrastructure has changed name to Amundi Funds Equity India Infrastructure. Effective 2 March 2010, CAAM Funds India Infrastructure has changed name to Amundi Funds India Infrastructure.

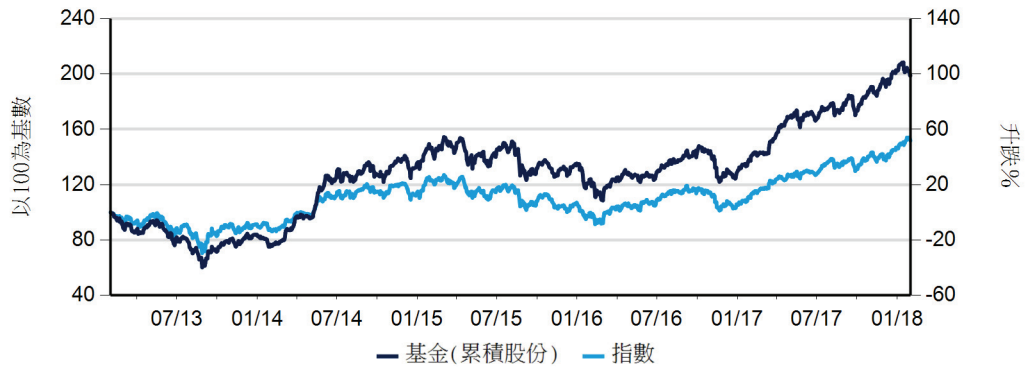

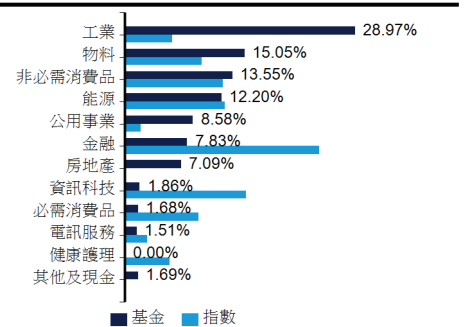

從二零一七年七月三日起，子基金的投資目標及政策被修訂。從二零一三年二月十二日起，香港股東在子基金的A U類別之股份已自動轉換至A 2 U類別，並採用與A U類別當時的費用及收費結構。在二零一三年二月十二日之前子基金A 2 U類別的表現依據東方匯理系列基金印度基建基金A U類別之表現計算，而A U類別已非證監會認可的基金類別及其不能向香港公眾發售。自二零一一年七月十五日起，本基金的參考指標將由100%印度孟買證券交易所Sensex 30指數改為10/40 MSCI China。東方匯理系列基金印度基建投資基金於二零一一年六月二十四日改名為東方匯理系列基金印度基建基金。東方匯理C A A M系列基金印度基建投資基金於二零一零年三月二日易名為東方匯理系列基金印度基建投資基金。
