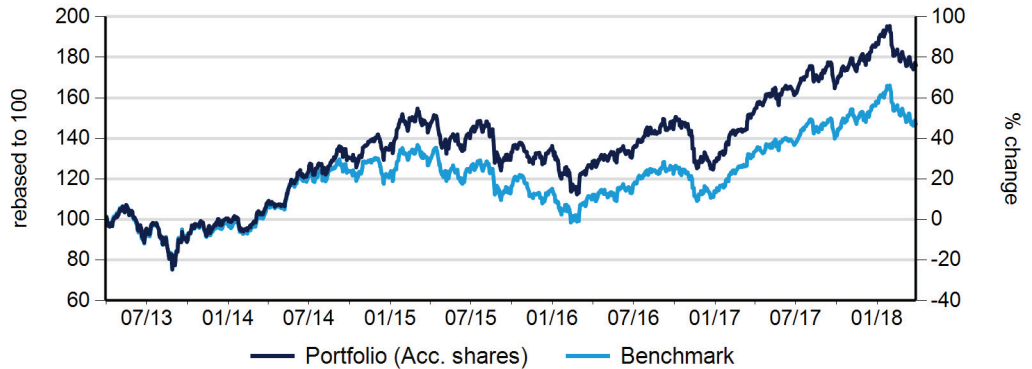

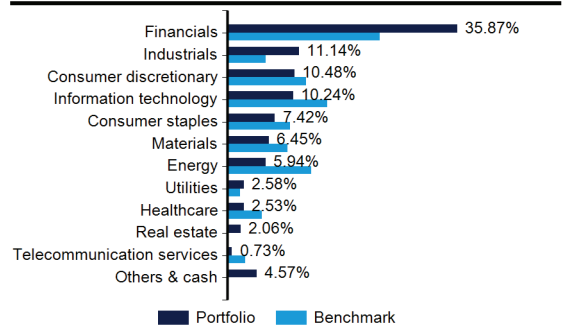

Effective 13 March 2017, Amundi Funds Equity India has changed name to Amundi Funds SBI FM Equity India. Effective 24 June 2011, Amundi Funds India has changed name to Amundi Funds Equity India. Effective 2 March 2010, CAAM Funds India has changed name to Amundi Funds India.

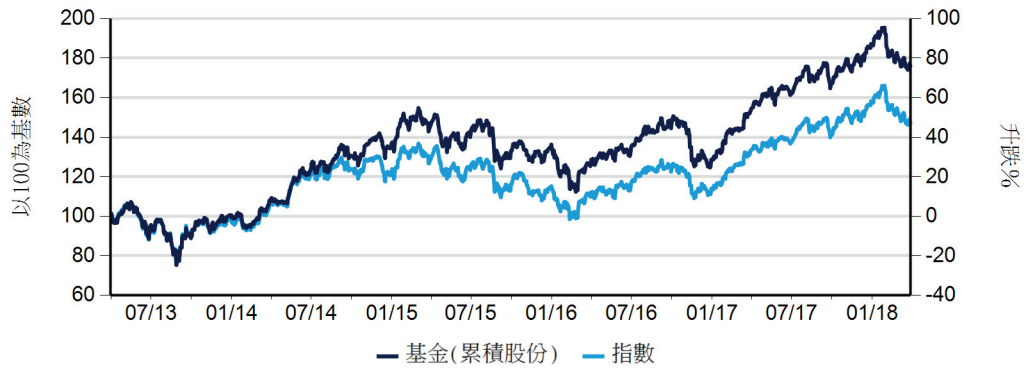

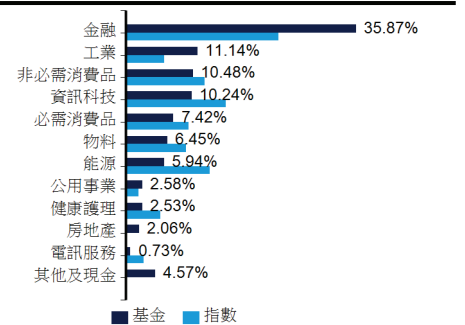
