Equity 股票

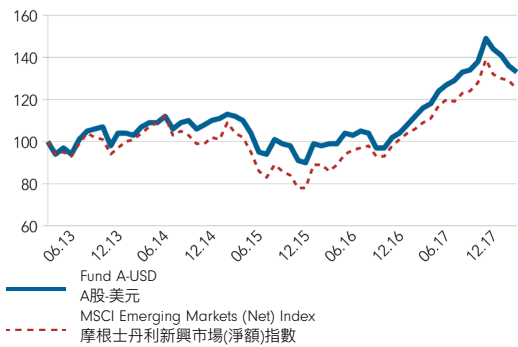

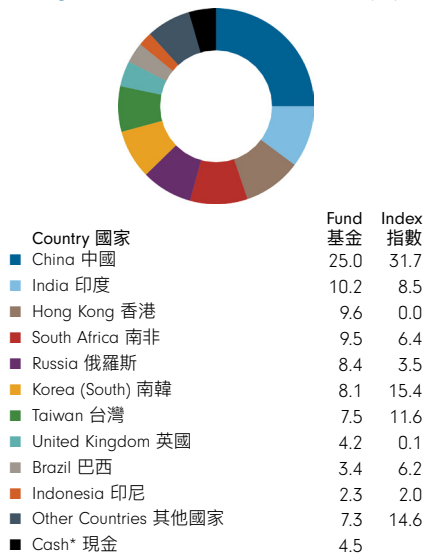

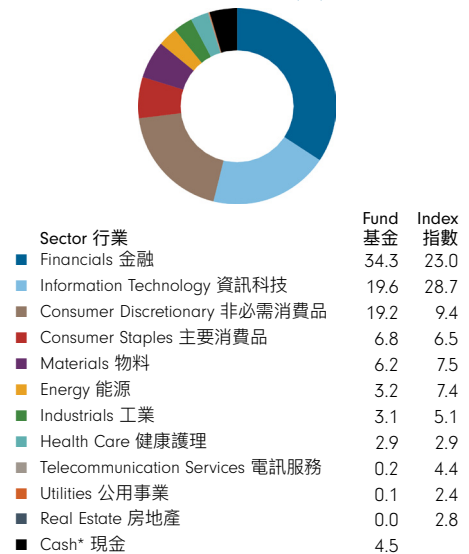
