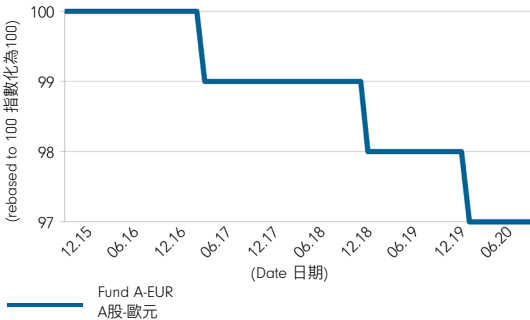
- This fund invests primarily in Euro denominated debt securities, including cash and cash equivalents.

About The Fund 基金概要

The fund is a Cash fund and aims to provide a return in line with money market rates where both capital security and liquidity are primary considerations from professionally managed portfolios of Money Market Instruments and other assets permitted by law in different geographical areas and currencies, with the opportunity to achieve the objective of regular income and high liquidity. The fund invests principally (i.e. at least 70% (and normally 75%) of the fund's assets) in Euro denominated debt securities and other permitted assets, including cash and cash equivalents and, within the restrictions imposed by law, Money Market Instruments, reverse repurchase agreements and deposits.
