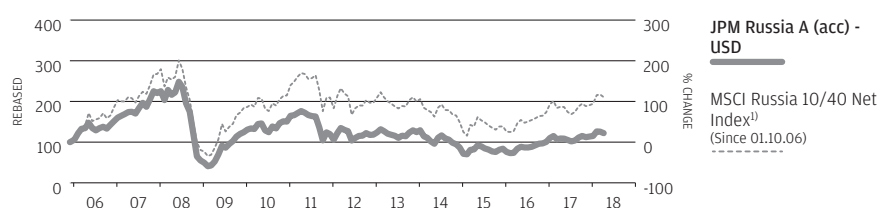

PERFORMANCE FROM 22.11.05 TO 29.03.18 (in denominated currency)



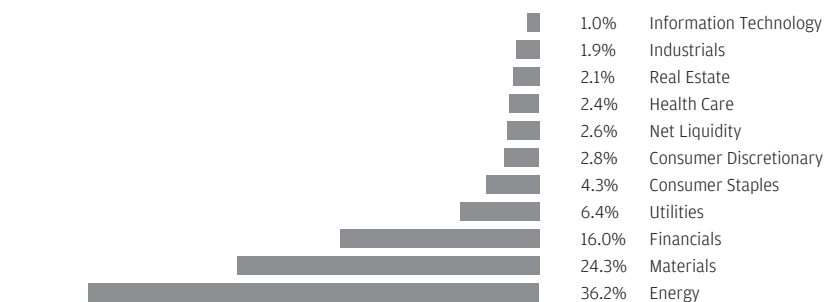
