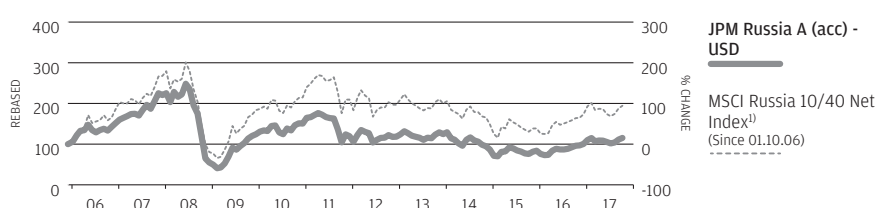

PERFORMANCE FROM 22.11.05 TO 29.09.17 (in denominated currency)



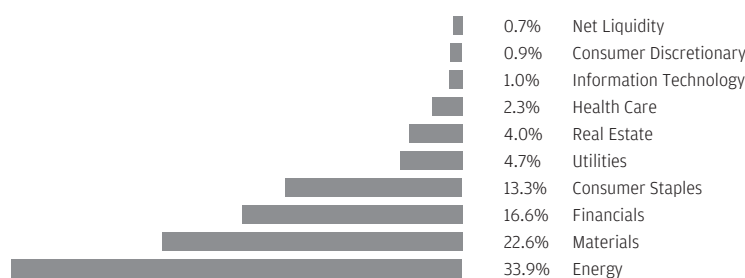
