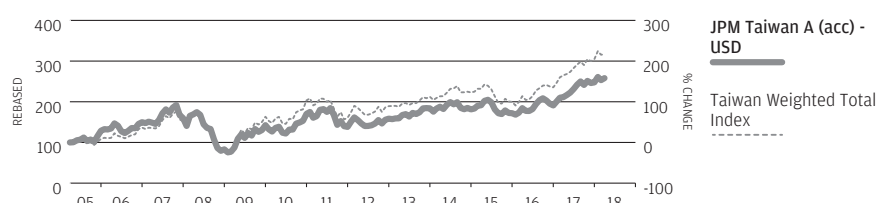

## PERFORMANCE FROM 31.03.05 TO 29.03.18 (in denominated currency)



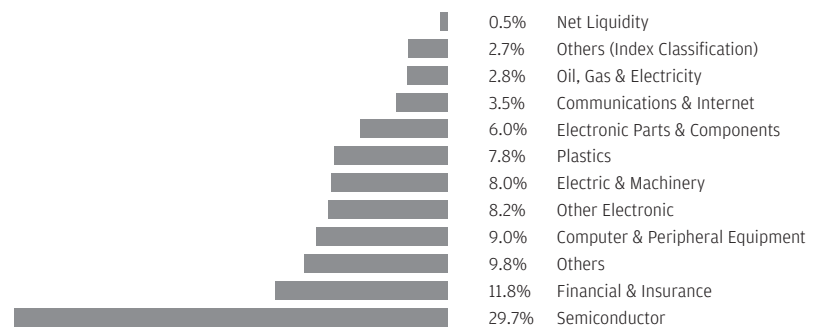
