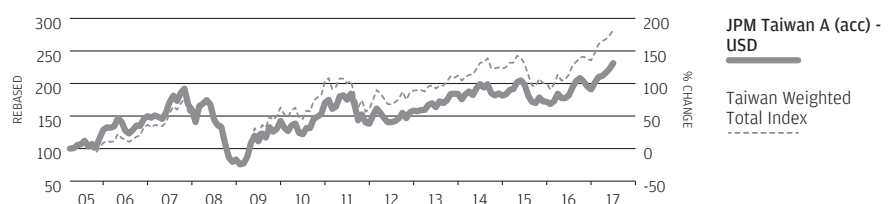

## PERFORMANCE FROM 31.03.05 TO 30.06.17 (in denominated currency)



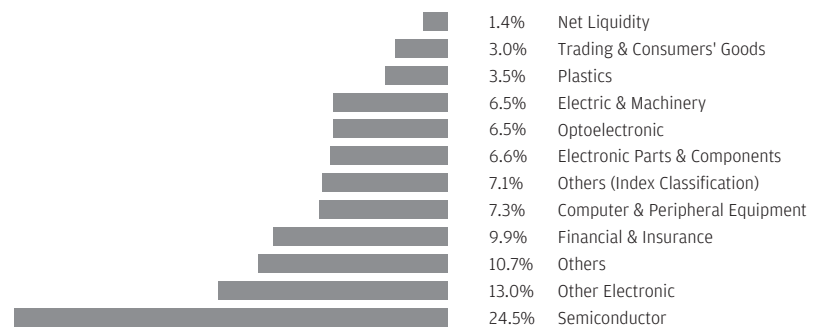
