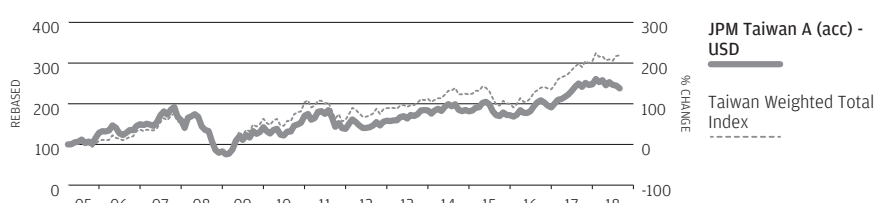

PERFORMANCE FROM 31.03.05 TO 31.08.18 (in denominated currency)



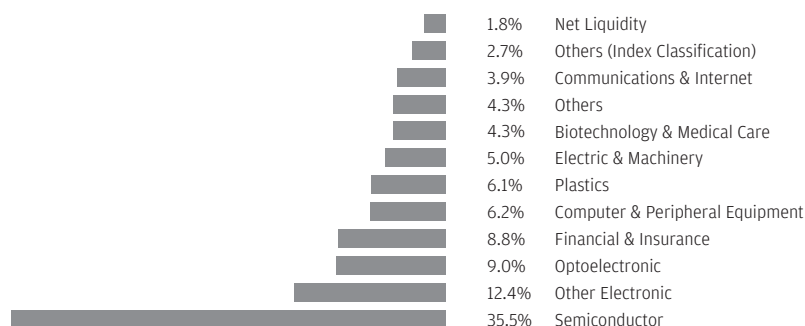
