Important Information 重要事項

The fund invests primarily in equity and equity related securities of companies in the energy sector.

Where distributions are paid out of capital, this amounts to a return or withdrawal of part of your original investment or capital gains attributable to that and may result in an immediate decrease in the net asset value of shares.
