Procedures for receiving the designated Day Case Procedure at a Designated Healthcare Services Provider

第 1 步: 受保人可致電服務熱線預約。

Step 1: The Insured Person can dial the service hotline to make a reservation.

第 2 步: 我們的醫護管理團隊將安排特選專科醫生為客戶提供醫療意見及服務，客戶可諮詢專科醫生需要進行指定日間手術與否。

Step 2: Our healthcare network team will arrange a medical consultation with a Specialist for the Insured Person. The customers shall consult with the Specialist and be advised if the designated Day Case Procedure is required.

第 3 步: 如該專科醫生建議受保人進行指定日間手術，受保人將轉介去進行指定日間手術，而該指定日間手術將於客戶自選指定醫療服務提供者的醫療網絡進行。

Step 3: If the Specialist recommends the Insured Person to receive the designated Day Case Procedure, the Insured Person shall be referred to conduct the designated Day Case Procedure which will be performed at the healthcare network of a Designated Healthcare Services Provider that the Insured Person has chosen.
