

## iFWD Provie 真息揀月繳儲蓄保險四月推廣條款及細則

1. iFWD Provie 真息揀儲蓄保險四月推廣（「此推廣」）只適用於申請由富衛人壽保險（百慕達）有限公司（「富衛」）所承保的 Provie 真息揀理財壽險計劃之月繳計劃（「Provie 真息揀」）。
2. 此推廣的有效期為 2018 年 04 月 01 日至 2018 年 05 月 31 日（包括首尾兩天）（「推廣期」）。
3. 此推廣只適用於**新客戶**於推廣期內投保「Provie 真息揀」。「**新客戶**」指客戶從未曾持有任何「Provie 真息揀」之保單。
4. 在此條款及細則約束下，「Provie 真息揀」申請人可享受：

### (1) 首次保費折扣

如「Provie 真息揀」申請人的出生年月日（「出生年月日」）包含「2」或「8」或「9」。保費折扣將根據其出生年月日出現數字「2」或「8」或「9」的總次數及下列圖表而定：

<sup>^</sup>在月繳計劃下，首次保費是相等於首兩個月之月繳保費。

### (2) 保費回贈

「Provie 真息揀」申請人同時可享相等於第一個保單年終結時保單戶口價值(釋義如下)的 2% 回贈並以保費折扣形式繳付下一期保費。下一期淨保費會通過申請人之直接轉帳授權之銀行戶口收取。

6. 戶口價值指「Provie 真息揀」保單下已繳付保費總額，加上派息（如有），減去部份退保（如有）和所有附約下之保費（如有）。
7. 此推廣不能作現金兌換及回贈只可用於繳付其「Provie 真息揀」保單之下一期保費。倘若「Provie 真息揀」的保單在回贈以保費折扣形式繳付下一期保費前被取消或退保，回贈將不能被提取。

- iFWD Provie Monthly Contribution Saving Insurance April Promotion ("this Promotion") is only applicable to the applications for monthly contribution plan of Provie Insurance Plan ("Provie") underwritten by FWD Life Insurance Company (Bermuda) Limited ("FWD").
- This Promotion is valid between 01 April 2018 and 31 May 2018 (both dates inclusive) ("Promotion Period").
- This Promotion is only applicable to **new customers** who purchase Provie within the Promotion Period. "**New customers**" means the customer who has never held any Provie policy.

<sup>^</sup>For monthly plan, the Initial Premium Paid is equivalent to first 2 months' regular contribution.

### (2) Premium Rebate

The applicant of Provie can at the same time enjoy a rebate equivalent to 2% of the Account Value (as defined below) at the end of the first policy year in form of premium discount to settle the next premium due. The net premium for such next premium due shall be collected from applicant's bank account via direct deposit authorization.

- The premium above-mentioned does not include insurance levy to be collected by the Insurance Authority. Insurance levy is calculated based on the premium before discount. Once it is confirmed Provie meets the Applicant's objective(s) and need(s), applicant must present his/her HKID Card proving his/her eligibility of this Promotion and enjoy the premium discount on the initial premium paid. The discounted premium must be paid by one of the following payment methods at the time of submission of the application of Provie within the Promotion Period:

If the policy of Provie issued is cancelled at any time within the first 12 months from the policy issue date (including the cooling off period), FWD will only refund actual premium paid and levy paid by the policy owner. If the policy owner surrenders respective policy at any time within the first 12 months from the policy issue date, the premium discount shall be fully deducted from the surrender benefit and there will be no refund of the levy paid.
11. In any event, each applicant can only hold at most ONE (1) POLICY of the Plan through any means of application (including any terminated Plan). Any applicant who already holds one policy of the Plan is unable to make any further applications through any method.
